# Wireless Telecommunication Engineering Technology (WTET) Restructuring Plan

Motion (Meridji/Ward): that the Council approve ACC's plan to restructure the existing Wireless Telecommunication Engineering Technology (WTET) program as follows:

- To replace the title Wireless Telecommunication Engineering Technology (WTET) with the title Communications Engineering Technology (Wireless) Diploma (CET Wireless);
- To offer a 15-seat Communications Engineering Technology (Wireless) Diploma as a 2-year program, beginning in the 2010-11 academic year;
- To offer a 15-seat Electronic Technician Certificate, as an exit point for students at the end of year one, beginning in 2009/10 academic year; and
- To fund these programs with existing ongoing base-funding from COPSE in the amount of \$248.6.
