College Expansion Initiative

Assiniboine Community College

Business Information Management Diploma

Motion (Turner/Macdonald): that the balance of the College Expansion Initiative budget for 2001/02 be transferred to Assiniboine Community College to pre-fund a portion of the 2002/03 costs of the Business Information Management Diploma [thus reducing the requirements of that program by an equivalent amount in 2002/03], and

that the College be authorized to use these funds in 2001/02 to cover the costs of additional consulting work relative to the Brandon Mental Health Centre proposal.

Motion (McKay/Macdonald): that Council approve the new Civil/Computer Aided Drafting (CAD) Technology Certificate Program in the amount of \$143.7 in the first year (2002/03), and \$126.2 in the second and subsequent years.

Brandon University

• Bachelor of Science (Distributed Major)

Motion (McKay/Samatte): that Council approve the development of the Bachelor of Science (Distributed Major) as presented, and

that Council recommend that Brandon University cover the requested \$10.0 in funds for marketing the program from within its existing budget.

CARRIED

Motion (Turner/McKay): that Council approve in principle, the concept of the development of a Centre of Excellence in Transportation and Logistics. To this end, that the Council allocates \$100.0 to the University of Manitoba to enable the University to start the undergraduate component of the program, and, if possible, a portion of the masters program. Additional funding will be reconsidered at a later date after all private sector contributions have been solidified.
