8312 Introduction to Hairstyling (10A) 20S/20E/20M

Course Description

This course introduces students to hairstyling, with a focus on safety and sanitation, basic tools and equipment, the operation of a hairstyling salon, the workings of the industry, and introductory skills such as braiding, thermal styling, and roller setting. Students learn all of Unit B2: Sanitation and Decontamination in this course.
