MATURE STUDENT GRADUATION REQUIREMENTS

Purpose of Handbook

The purpose of this handbook is to provide Senior Years school administrators and adult learning centre (ALC) directors with information about policy requirements related to *Senior 1 to Senior 4 Mature Student Graduation Requirements (2003)*.

Introduction

A provincial graduation diploma requires the successful completion of 28 credits across Senior 1 to 4. For “mature students” an alternative route to graduation is available. The *Senior 1 to Senior 4 Mature Student Graduation Requirements (2003)* sets out the requirements for the Mature Student High School Diploma. Manitoba Education and Youth and Manitoba Advanced Education and Training, with their commitment to lifelong learning, believe that it is important for adults to have additional opportunities to graduate from Senior Years.

Mature Student Eligibility

A “mature student” eligible for obtaining a Mature Student High School Diploma under the *Senior 1 to Senior 4 Mature Student Graduation Requirements (2003)* is one who:

- (a) is 19 years of age or over at the time of enrolment in school division/district or ALC programming directed at completing the Mature Student Graduation Requirements, or one who will reach the age of 19 before completion of the course(s) in which one is enrolled;
- (b) has been out of school six months or more, and out of school long enough for the class, of which one was last a member, to have graduated from Senior Years; and
- (c) has not obtained a high school diploma.

Students can enrol in a school division/district or ALC for the purpose of obtaining the Mature Student High School Diploma if they are eligible as described above.

Mature Student Graduation Requirements

The purpose of the *Senior 1 to Senior 4 Mature Student Graduation Requirements* (2003) is to enable eligible mature students to graduate from Senior Years by obtaining a Mature Student High School Diploma. The Mature Student Graduation Requirements outlined in this document are consistent with graduation requirements as described in *Increasing Choice and Flexibility: Changes to Senior Years Graduation Requirements* (March 2001) and *Increasing Choice and Flexibility: Changes to Senior Years Graduation Requirements Status Report* (2002).

Programming

1. Mature Student Graduation Requirements for English, Français, French Immersion, and Senior Years Technology Education Programs consist of eight credits (see charts on following pages).
2. Enrolment can be on a part-time or full-time basis.
3. The mature student must ensure that the requirements of the post-secondary education, training, or work situations he or she intends to pursue are met. School divisions/districts and ALCs support students in learning about post-secondary requirements.
4. Compulsory credits in language arts and mathematics successfully completed toward one of the four school programs prior to enrolment can be transferred toward completion of the Mature Student Graduation Requirements. Additional credits can be transferred to meet Mature Student Graduation Requirements (see charts on following pages).
5. Courses designated as G (General), F (Foundation), S (Specialized), A (Advanced), M (Modified), E (English as a Second Language), U (University), and C (College) are accepted for Mature Student Graduation Requirements.
6. Mature students are required to write Senior 4 standards tests in compulsory subject areas. Exemptions can be made in accordance with the Department's current Policies and Procedures for Standards Tests, available online at <www.edu.gov.mb.ca/ks4/assess/publications.html>.
7. Mature students cannot obtain retroactive mature student standing. The Mature Student High School Diploma cannot be claimed solely on the basis of courses previously credited at Senior Years.

The charts that follow detail credit requirements for the various streams of the Mature Student High School Diploma. Normally the required Senior 4 courses (four credits) will be completed by the student while enrolled in the Mature Student Diploma Program, and the four additional credits may either be completed while the student is enrolled in the Mature Student Diploma Program or carried forward from previously completed high school credits, literacy programs, or Adult Basic Education (ABE). From the tables, you will also see that, like the English program, both the Français and French Immersion programs have four compulsory Senior 4 credits.

In the event that the student has previously completed some of the required Senior 4 credits, the principal of the school or principal of the Distance Learning and Information Technologies Unit or education director of an ALC will have discretion to carry these forward as well. However, in determining the most appropriate combination of credits for the student to obtain the Mature Student Diploma, it is important to consider the currency of previously completed credits. Credits completed more than 10 years ago should not be carried forward without permission of Manitoba Education and Youth or Manitoba Advanced Education and Training.

8. School divisions/districts, schools, and ALCs cannot set requirements for obtaining a Mature Student High School Diploma other than those set by Manitoba Education and Youth or Manitoba Advanced Education and Training.

Roles and Responsibilities

9. The principal of a school in a school division/district, the principal of the Distance Learning and Information Technologies Unit, or the education director of an ALC is responsible for tracking student progress and ensuring that the requirements are met prior to a mature student obtaining a Mature Student High School Diploma.
10. The principal of a school in a school division/district, the principal of the Distance Learning and Information Technologies Unit, or the education director of an ALC is responsible for assessing students' previous learning experiences and determining transferability of credits.
11. A Mature Student High School Diploma and a transcript issued by the school or ALC will be granted to mature students on completion of the Mature Student Graduation Requirements. The transcript must include the courses completed by the student, including course designations (see *Subject Table Handbook*).

Other

12. There is no time limit for completing Mature Student Graduation Requirements. The length of time needed to complete Mature Student Graduation Requirements depends on the program chosen and the number of credits a mature student is able to transfer toward the Mature Student High School Diploma from previous learning experiences (see charts).
13. Credits can be completed through the Distance Learning and Information Technologies Unit, a school or an adult learning centre, or through a dual credit arrangement with a post-secondary institution. *Any credit, including required credits, may be completed by a mature student through Prior Learning Assessment or the Challenge for Credit Option.* Substitution of credits does not apply to the Mature Student Diploma.
14. Departmental requirements related to “schools of choice” and “program(s) not offered locally” apply to each mature student until June 30 of the calendar year in which the mature student turns 21 years of age, or until the mature student achieves a graduation diploma, as defined in regulation, whichever comes first.¹ For this cohort of mature students (who are **not** students of an ALC), transfer and residual fees apply, and these mature students cannot be charged a tuition fee(s). “Schools of choice” and “program(s) not offered locally” do not apply to any mature student who is 21 years of age or older, nor to any mature student who has previously achieved a graduation diploma, as defined in regulation. For this cohort of mature students, transfer and residual fees do not apply, and the mature students can be charged a tuition fee(s). Please refer to Appendix C in *Funding of Schools* for the current year.² Note: Paragraph 14 does **not** apply to students of an ALC.
15. Funding to school divisions for *individual* students enrolled as mature students will continue as in the past. Funding for adult-specific programs at schools or ALCs is based on the programming offered and must be applied for with the Adult Learning and Literacy Branch.

Implementation

- Effective immediately, all schools and adult learning centres should implement these Mature Student Graduation Requirements.

Phasing Out *Mature Student Graduation Requirements* (1988)

- By the end of the 2000/2001 school year, all schools were required to phase out the *Mature Student Graduation Requirements* (1988) for all mature students.
- Effective the 2001/02 school year, all mature students had to complete programming under the *Senior 1 to Senior 4 Mature Student Graduation Requirements* (1999), including any returning mature students who began programming under the 1988 requirements.
