Caleb Courcelles, Grade 2

Language Arts:

Caleb completed the remaining three units out of his six unit Steck-Vaughn Spelling Linking Words to Meaning Level 2 program, scoring an average of 86% on each lesson. As the second half of the year progressed, Caleb improved in using the suggested spelling strategies, as well as starting to create some memory clues. Caleb's use of words in context in sentences has also improved with Caleb writing longer sentences.

For reading, Caleb completed the Complete Reading Grade 2 by Essential Skills. Caleb appears to have developed a bank of sight words, relying less on phonics to read words. When asking Caleb how he just knew some of the words, he said he used some clues he had been practicing in his spelling. Caleb's understanding of what he reads seems improved as he often asks, 'I wonder' questions when he talks about what he has been reading.

Caleb is much more willing to try to write stories he makes up than he did earlier in the year.
